The \$66.4 million Broadband Technologies Opportunity Program stimulus grant, awarded by the National Telecommunications Infrastructure Administration will fund 70% of the \$94.0 million project, with Horizon providing the remaining 30%. These monies are for the middle mile fiber for rural areas in Appalachia. Columbiana County is one of the rural Ohio counties that will benefit from the fiber optic network in Appalachia. "Having this access will improve Internet connectivity to our residents and businesses and by linking them, will improve our economic growth." The three local development districts was the driving force behind the application process. In our region OMEGA helped garner support for the application.
