RE: PUBLIC HEARING SALES TAX 1% RENEWAL

Commissioner Halleck opened the public hearing meeting on the 1% sales tax renewal asking for any comments. Mr. Dyce we need you to say something.

John Dyce stated he is pretty disappointed that more members of the community are not here.

Commissioner Halleck said he understands that there was an email blast last night and they didn't seem to show up.

John Dyce said people need to be informed number one; I don't know how this was publicized. Most people I spoke to didn't know about the first meeting and they didn't know there was going to be a second meeting.

Commissioner Hoppel stated it was advertised in the paper according to the Ohio Revised Code.

Mr. Dyce said he understands that you met the requirements of ORC, however, most people just simply don't read those.

Mr. Tom Giambroni stated it was a front-page story in all three papers within the past four weeks.

Mr. Dyce said that in four weeks most people simply forget and need constant reminding since most people are consumed with their lives and they won't be here and in a couple of months will see you on the streets and will call to complain to you about how did you do that. I'm just saying that the commissioners have done their due diligence as required.

Commissioner Halleck stated he appreciated his comments and you are certainly welcome to those. Since we talked last, I can tell you, an income tax, I've not met one person from either party that thinks that's a good idea. Having said that though, when you don't have, and I've been here on and off for a lot of years, people, they will let you know if they're not happy. Most people including office holders of both parties and as I said, I just talked to two of them this morning coming in, people are pretty much happy. Now we can argue about how we get the roads, cause, there's a lot of roads, but for the most part nobody disagrees that a sales tax is the fairest tax, only because such a large amount of it does have to be paid. You know it's always nice for someone else to pay your bills and we have the people from the outlying areas that pay them. The other thing that someone pointed out we all go to Boardman or Columbus or wherever we travel, we pay it, we don't complain about that. Its just the cost of doing business and it is the fairest. The income tax thing would disturb a lot of people because even on your retirement they may not reach the threshold in personal income tax but people on social security or whatever if it's tied to other income you reach a certain threshold, you're going to pay on that. So, I guess that I'm saying is by virtue of a lot of people not coming, I'm going to say they rubber stamp us as doing a great job but I think most people think we're doing an acceptable job at this point. There is a lot of other things we can be debating, and rightly so, how we get there, but I think on the sales tax the majority of the people are comfortable. I think, what was it last time, do you remember?

Tom Giambroni, I did look it up, it was like 56%;

Commissioner Hoppel stated 67%-30%, it was pretty high

Mr. Giambroni said he didn't think it was that high, I thought it was in the high 50's.

Commissioner Halleck said he usually keeps those things up here, I don't have it.

Commissioner Hoppel said it was in the 60's, he's almost positive.

Commissioner Halleck, be that as it may, your point is well taken. I have no objection to people coming in here, they can be as mad as a hornet, that's what we're here for. That's what you run for, and you've been through it. I'm sure you ran, and people said, I'd never vote for you, cause you feel this way.

Mr. Dyce stated: I already did, next month when I run for the election for state president.

Commissioner Halleck, there you go. So, I've dealt with it. It doesn't bother me. This Lisbon talk thing, it's a side topic, but I had to smile cause people are getting on there putting all these things. Some of these pictures are old as, that's a whole other story I was looking into today, laughing about.

Mr. Dyce said my whole concern is low income people, taxes everywhere are increasing; our sales, gasoline tax will go up in just a few days. Lisbon is looking at an income tax, East Palestine is looking at a fee. Just trying to cope with loss of income and the need to deliver the services to the people. I'm retired. I'm on a fixed income. Everything goes up but my income. All the fees and taxes, are always going up and I'm not alone in that situation. There're many people in this county, those are the ones that I'm really concerned about. I see a lot of them throughout the week.

Commissioner Halleck replied there's nobody hates taxes and more concerned them I am when it comes to money, but I can tell you if you're going to have guys like him (talking about a person in attendance) going to work in the morning building roads, and bridges and things, what's your answer?

Mr. Dyce replied we need money absolutely.

Commissioner Halleck, if I had a magic wand it would be one that we could just say nobody pays any taxes. That would be a perfect world for me, but you're not going.......

Mr. Dyce, quick story: Ten years ago, when I first got elected state president, I took over an organization that was in financial dire, we all knew we had to do something with the state-wide organization. I sat down, met with my executive board, met with people from around the state. I looked at a plan that we knew that raising our per capita, what we pay in, what our members pay into the state we expect to be acceptable for people because they don't want to pay more money out of that. So, I developed a plan with our resources that we had coming in, our payments and our services that we were required to do, but improve and enhance those and I did so. I had to change a lot of long-standing practices but we did it and now today we're in, ten years later, we're in better financial condition and we're doing a lot more legislative work than we've ever done.

Commissioner Halleck replied, so what your saying is you found a lot of waste.

Mr. Dyce, yes, and sometimes that takes people willing to say well, we're going to change this. I've heard many times, well, that's they way its always been. It might be so, but it might not have been the best way.

Commissioner Halleck: you're right. It's no different privatizing the jail. Everybody, well not everybody, I think people accepted. Is it perfect? No. Can someone else run it better? Maybe. But at what point do you reach diminish and returns? Is it worth 25 million dollars? Most people say no, I'm not paying more in taxes so criminals can be in jail. So those are decisions that we make. Maybe someday you'll be here making with us, who knows. They are tough decisions, but I think for the most part, people I've talked to, you're always going to have those haters, and I ignore those. I ignore social media. I don't even comment on that crap anymore. That's, people that want to sit in the basement staring at the screen all night so they can think something mean to say to other people, they're not very intelligent, in my view, and there's a lot of those people, unfortunately. Anyway, I'm glad you came again.

Mr. Dyce: I would never miss it.

Commissioner Halleck: Anything else to come. No sir. Hearing no further comments.

Commissioner Weigle: Motion to move forward to putting the sales tax on the ballot in the next election in

November.

## RESOLUTION NUMBER 26-2019

A RESOLUTION TO PLACE ON THE NOVEMBER 2019 GENERAL ELECTION BALLOT CONTINUATION OF A COUNTY ONE PERCENT PERMISSIVE SALES AND USE TAX PURSUANT TO SECTIONS 5739.021 AND 5741.021 OF THE REVISED CODE.

WHEREAS, the Board of Commissioners has determined that there is a present need for additional revenue to insure the continued operation of the several offices, departments, and agencies of Columbiana County, Ohio;

NOW THEREFORE, be it resolved by the Board of Commissioners of Columbiana County, Ohio, that:

- 1. For the purpose of providing additional general revenue for Columbiana County and paying the expenses of administering the levy, the Board of Elections is hereby directed to submit the question of levying a one percent (1.0%) tax on every retail sale made in Columbiana County, Ohio, except sales of watercraft and outboard motors required to be titled pursuant to Chapter 1548 of the Revised Code and sales of motor vehicles, in addition to the tax imposed by Sections 5739.02, 5739.023, and 5739.026 of the Revised Code, at the upcoming general election on November 5, 2019.
- 2. For the purpose of providing additional general revenue for Columbiana County and paying the expenses of administering the levy, the Board of Elections is further directed to submit the question of levying a one percent (1.0%) tax on the storage, use, or other consumption in Columbiana County of the following: (a) motor vehicles by a transaction subject to the tax imposed by Section 5739.02 of the Revised Code; and (b) in addition to the tax imposed by Section 5741.02 of the Revised Code, tangible personal property and services subject to the tax levied by this state as provided in Section 5741.02 of the Revised Code, and tangible personal property and services purchased in another county within this state by a transaction subject to the tax imposed by Section 5739.02 of the Revised Code, at the upcoming general election on November 5, 2019. This tax on the storage, use, or other consumption of tangible personal property and on the benefit of a service realized shall be in addition to the tax levied by Section 5741.02 of the Revised Code and, except as provided in division (D) of R.C. 5741.021, any tax levied pursuant to Sections 5741.022 or 5741.023 of the Revised Code.
- This Resolution is adopted pursuant to and in accordance with Sections 5739,021 and 5741,021 of the Revised Code.
