## RE: MUTUAL AID AGREEMENT - COVID-19, LOCAL ACCOMMODATIONS

This agreement is not to be used to establish alternate care sites or temporary hospitals for individuals requiring hospitalization. The contract will be reviewed by our legal department before signing.

Update from Health Commissioner Wes Vins (via Zoom) regarding the COVID-19. He commended the State of Ohio and Columbiana County for doing a good job of keeping numbers down.
