He explained he was not here for political presence but to get answers to things people have brought to his attention. One item he found particularly disturbing is the "pig post" regarding wasteful spending, fraud of workers compensation and overtime/hiring for friends posted on Commissioner Paparodis face book page.

Commissioner Paparodis was curious why he waited until today, one week before the election, to bring this to the meeting and Mr. Cranmer explained that he was already scheduled on the agenda before he received this information.

Commissioner Weigle gave explanation on the workers compensation and overtime stating the night of the train derailment, those present on scene were advised to be evaluated at the clinic that was set up in East Palestine. He, among others, including the volunteer for the County EMA were seen. The volunteer was advised to seek follow-up medical attention for his symptoms; which in turn ended up being a workers compensation claim. There were many hours spent after the night of disaster to secure the site and oversee necessary precautions. Commissioner Weigle stated if there was fraud committed, he would step down tomorrow and he also asked for Commissioner Paparodis to remove himself from running for re-election. Norfolk Southern is working with the Ohio BWC to reimburse any claim for first responders related to the train derailment. Any information regarding workers' compensation should not have left our office as it is a HIPAA violation.

Commissioner Paparodis stated he wasn't the author of that post, and he didn't sign off on any workers compensation approval.

Commissioner Halleck agreed the "pig post" is distasteful. He offered a timeline of the workers' compensation claim in question and stated that information should not be on the streets and however it left the office was not appropriate. There was no fraud involved.

Mr. Cranmer's next item to discuss was regarding the Board of Revisions real estate valuation of property valuation and gave Commissioner Paparodis a printout of a face book post. Commissioner Paparodis stated he has not seen this information before today, wanted to know the author and why he was bringing gossip to this office one week before the election. Mr. Cranmer stated he was here to ask the questions. Commissioner Paparodis stated he would do the research on the real estate question.

In a prior meeting Mr. Cranmer asked Commissioner Paparodis if he ever received grant money and stated he since found information that BB Rooners did apply for a grant and questioned his statement on not raising taxes but using tax money to obtain the grant. Commissioner Paparodis stated that BB Rooners did not apply for the grant, the RODI Group did. Commissioner Paparodis stated the Governor of Ohio granted money for our region to be used to help our area.

Another item Mr. Cranmer had questions on was the ARPA spreadsheet he was supplied with at a prior meeting and wanted to know if the Board has provided money to East Palestine to aid with the disaster. Commissioner Halleck stated there was such an influx of funding from other sources and Treasurer Blakeman stated his office waived late fees for every taxpayer in East Palestine.

Mr. Cranmer questioned the county liability portion of the settlement of the reporter case and Commissioner Halleck stated our percentage is our deductible. Mr. Cranmer questioned the prior report Commissioner Paparodis presented on the Land Bank, specifically the ELO Maryland remediation. Mr. Tad Herold spoke regarding the cleanup process and how it was handled.

One last item Mr. Cranmer asked was if the ARPA spreadsheet could be published so the public can see where the funds are being spent. Commissioner Halleck stated we will take that under advisement.

Being no further business Commissioner Halleck adjourned the Commissioners regular meeting.
